Desirable Criteria: <ul style="list-style-type: none">• Local residents/ Proficiency in regional/ Local language• Work experience in the Public health system, preferably at the Primary Health Centres level• Candidates who are graduates from Government Training Institutes
<p><u>*The course is open to inservice (a) regular employees (b) contractual employees under HM&FW for H&WCs.</u></p> <p>** the courses are also open to BSc Nurses provided they are willing to work in Sub centres</p> <p>***In case, in service candidates are being chosen. Current monthly emolument should not be more than the proposed emolument for CHOs</p> <p>**** Candidates will have to sign a bond to serve in Sub centres for at least 3 years after the training</p> <p>The Government will bear all the training expenditure incurred regarding above course.</p> <p>All the trainee qualified Staff Nurses should give under taking to work at sub centre level as</p>

mid level service providers and they will be paid salary of Rs.20,000/- (Rupees twenty thousand only) per month. In addition they will also be paid Rs.15,000/- (Rupees fifteen thousand only) per month as performance incentive.
