The attention of the District Medical and Health Officers in the state i.e., Member-Convener of the Selection Committee for Multi Purpose Health Worker (Female) / ANM Training Course in the State is invited to the reference 1st cited, the Government have issued instructions, that the MPHWF (F) Training Course admissions should be Online.

Accordingly, the online admission application for MPHWF (F) / ANM Training course of 1st year for the academic year 2024-2025 is available on the CH&FW official website <http://chfw.telangana.gov.in>. Hence, the following instructions have to be followed while making the admissions for Free (Convener) / Management quota seats in the Private MPHWF (F) Training Institutions available in their respective districts **only recognized schools registered as on date by Indian Nursing Council / TS Nurses Midwives Auxiliary Nurse-Midwives & Health Visitors Council**

Vide reference 5th cited, the following MPHWF (F) Training institute are eligible for admission notification for the academic year 2024-2025.

The **Online** application is available on the CH&FW official website www.chfw.telangana.gov.in. Hence, the following instructions have to be followed while making the admissions in the Private MPHWF Training Institutions available in their respective districts.

PROCEDURE FOR ADMISSION INTO MPHWF TRAINING INSTITUTIONS

EDUCATIONAL QUALIFICATIONS:

The Minimum Educational qualification for admission into the Multipurpose. Health workers (Female) Training Course shall be **Intermediate pass** with any group.

AGE: No upper age limit for Nursing Programmes as per the Notification No.11 of the Secretary, Indian Nursing Council, New Delhi Dated:21.08.2023 for MPHWF/ANM admissions and this is the approval of the Competent Authority.

CATEGORISATION OF SEATS: 60% of the total number of seats shall be called "Free Seats" and the remaining 40% shall be called "Management Seats"

METHOD OF ADMISSION: (1) Admission to "Free seats" shall be made by a selection committee consisting of the following:

The above committee shall make selections purely based on the merit, on the basis of aggregate marks obtained by the candidates in the minimum qualifying examination for Multipurpose Health Workers (Female) Training Course i.e., Intermediate Public Examination or its equivalent with any group. In declaring such merit, candidates who pass under compartmental system shall be placed after candidates who passed in a single attempt and other guidelines for finalizing the merit will be followed.

(2) The Principals of Private MPHWF Training Institutions shall admit candidates as allotted by the above committee on the basis of ranking assigned to them against 60% "Free seats"

(3) The maximum number of students to be admitted in an institution shall not exceed (40) forty except Surya Teja MHPWF Trg. Institute, Mancherial District with a intake capacity of (30) thirty and Sri Thirumala MPHWF Trg. Institute Siddipet with a intake capacity of (30) thirty. However, if infrastructural facilities, teaching staff etc., in an institution are found to be inadequate to train (40) forty students, Government have the right to permit a lesser number of students.

(4) Admission to "Management Seats" shall be done by the institution only after the list of students to be admitted is checked by the Selection Committee,

(5) After approval of the students selection list will be submitted to the CH&FW, TS, Hyderabad, before commencement of Training Course.

FEE STRUCTURE:

A maximum fee of Rs.1,000/- per month per head shall be charged for Free Seats. As regards to Management Seats, the fee shall not be more than five times the fee applicable for Free Seats. Government will have the authority to fix the maximum fee chargeable for free seats and also to fix an upper limit in respect of fee for the management seats.

RULES OF RESERVATION:

Rule of reservation shall be strictly followed while making selection for both free seats and management seats. Unfilled seats meant for reserved categories shall be kept vacant and shall not be filled up. The stipulations of local area reservations shall be followed as prescribed in the rules in force by the Education Department.

PERIODICITY OF ADMISSION:

All the MPHWF Training Institutions shall admit candidates uniformly once in a year as per INC regulations.

SUBMISSION OF ONLINE ADMISSION APPLICATIONS

Online admission Application form is available in the Commissioner of Health & Family Welfare, Telangana., Hyderabad official website i.e, www.chfw.telangana.gov.in

Following are the important dates to be noted

1. Online submission of admission applications through CH&FW, Telangana. website: www.chfw.telangana.gov.in from 16/10/2024 to 25/10/2024
2. Last date of payment of registration fee of Rs.200/-
In the form of DD in any nationalized bank payable at Hyd. 25/10/2024
3. Last date for submission of downloaded admission applications at Principals of Private MPHWF Trg. Schools/ DM&HOs: 26/10/2024
4. Selection process will be completed by 31/10/2024
5. Commencement of classes will be from 01/11/2024

Following are the given steps for uploading the online admission application.

Step: 1: Fill up separate applications for "Free & Management quota seats" available in the particular district in Private MPHWF Training Institutions.

Step:2: Log on to Commissioner of Health & Family Welfare Official Website i.e., chfw.telangana.gov.in for online application form. Fill up all the mandatory fields (*) as per the instructions given in the online application and press submit button. Scan and Upload the candidate photograph without fail.

Step: 3: Download / Print the filled in application form and submit to the concerned Training Institute selected for admission / DM&HOs of concerned district in case of Private along with photocopies of the following documents.

- (I) SSC Certificate
- (II) Intermediate Certificate
- (III) Caste Certificate (in case of SC/ST/BCs)

- (IV) Residential Certificate/Study Certificate from IVth to Xth class as enclosures to the application form.
- (V) Registration fee of Rs. 200/- (Rupees two hundred only) by way of D.D. in favour of Commissioner of Health & Family Welfare, Telangana, Hyderabad payable at Hyderabad has to be enclosed to the application form and submit within the time to this office (DD period 03 months) without fail.

Step:4: There is no need to submit the application manually. Only Downloaded applications will be considered for selection.

Step:5: The last date for submission of downloaded applications to the concerned DM&HOs in case of Private MPHWF Training Institutions on or before **26/10/2024** by 5.00 PM (for Free and Management Quota Seats) either in person or by Registered post with due acknowledgement.

For the Management Seats also, the candidates are required to fill up the online application, download the filled-in application and submit the same to the selection committee for its approval.

The candidates also be informed that the recognition status of the MPHWF Training Institutions with regard to Indian Nursing Council/ Telangana Nursing and Midwifery Council can be verified in the respective websites 1)www.indiannursingcouncil.org 2) hmis.telangana.gov.in and **The department will not be held responsible for the admission of the candidates in a non-recognized institutions.**

The Department will not be held responsible for any postal delays for non-receipt of applications on or before the stipulated date i.e. 26/10/2024 by 5.00 PM


Entire process of selection has to be completed by 31/10/2024. As soon as the selection procedure is completed as per the above instructions and guidelines, the selection lists should be submitted to this office duly approved by the Selection Committee members on or before **16/11/2024** without fail. The selection list should indicate very clearly the number of candidates under free and management quota for each private nursing schools separately.

Hence, the District Medical and Health Officers concerned are requested to follow the above instructions strictly while making admissions for MPHWF / ANM Training Course in to 1st year for the Academic year 2024-2025 as per liability.

The District Medical and Health Officers are noted in the margin entry is also requested to issue suitable orders/instructions to concerned Principals of all private MPHWF Training Institutes in the state, to follow the principles of hygiene, social distancing must be advocated by all at all times to ensure the health, safety and security of the students, faculty and staff in view of COVID-19.
